UNANIMOUS WRITTEN CONSENT OF DIRECTORS IN LIEU OF SPECIAL MEETING RIDGESTONE HOMEOWNERS ASSOCIATION

Recitals

- The Board of Directors has determined that it is in the best interest of the Association to preserve, enhance and protect common elements where the Association is responsible, and
- The Board of Directors has determined that it is in the best interest of the
 Association to upgrade the fire monitoring system from analog communication to
 radio communication on thirteen (13) existing buildings, Exhibit A hereto attached,
 and
- 3. The Board of Directors has determined that it is in the best interest of the Association to hire Olympic Security and Communication Systems to perform the upgrade work, and
- 4. The Board of Directors has determined that it is in the best interest of the Association to borrow one half of the cost of contracted upgrade contract, \$5,640.14, from the reserve funds, and
- 5. The Board of Directors has determined that it is in the best interest of the Association to reimburse the reserve funds in twelve monthly installments, for the sum of \$470.01 beginning April 1, 2012 and ending March 1, 2013, and
- 6. The Board of Directors has determined that it is in the best interest of the Association to borrow one half of the cost of upgrade contract, \$5,640.14, from PULTE HOMES, interest free, and
- 7. The Board of Directors has determined that it is in the best interest of the Association to reimburse PULTE HOMES, in twelve monthly installments, for the sum of \$470.01 beginning April 1, 2012 and ending March 1, 2013, and

BE IT RESOLVED that the proposal by Olympic Security and Communication Systems for \$11,280.28 (includes sales tax) to upgrade the existing thirteen (13) buildings currently with analog communication to radio communication is accepted; and

BE IT FURTHER RESOLVED that \$5,640.14 will be borrowed from Reserve Funds and be reimbursed in twelve (12) monthly payments of \$470.01 beginning April 1, 2012; and

BE IT FURTHER RESOLVED that \$5,640.14 will be borrowed from PULTE HOMES and be reimbursed in twelve (12) monthly payments of \$470.01 beginning April 1, 2012.
